- 1. - 2. MINUTES FROM THE PARISH COUNCIL MEETING DATED 10th MARCH 2020. The minutes were approved and signed by the chairman as a true and accurate record, proposed HS, seconded TW.
- 3. PUBLIC FORUM Clerk reported there were no questions from the public.
- 4. FINANCE

- 5. Grass cutting the Chairman explained that the playground grass had not been cut. The playground bins had also not been emptied. Clerk to action.
- 6. Flooding the Chairman explained that the post office had been flooded.
- 7. Land Registry Search. Ongoing talks with Suffolk CC had resulted in a suggestion from Councillor Karen Soons for the Parish Council to undertake a land register search to establish ownership of the land and Councillor Soons had offered to reimburse the parish council for the cost. The Chairman Peter Royce expressed dismay at this request because at a meeting in July 2016 Councillor Soons attended with a resident to discuss the same issue, of drains in St Thomas's Way and on the advice and guidance of SALC it was agreed that the issue was a private one and, as such, as a public body the parish council is not permitted to spend public money to resolve a matter for which only a few private individuals would benefit. It is disappointing that the same request is now being made and Great Whelnetham PC have

- once again sought advice and clarification from SALC which reiterates the previous recommendation, of July 2016.
- 8. The Chairman, PR, has given up 3 months of his own time to research and establish the facts for the residents which was previously presented in January 2017. Council in full agreement that the PC is not required to undertake a land registry search.
